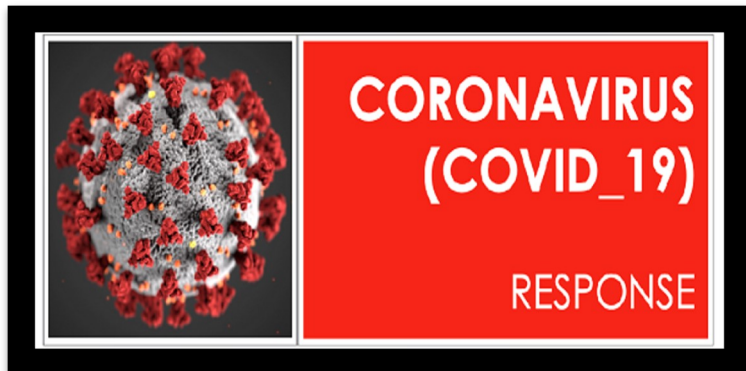

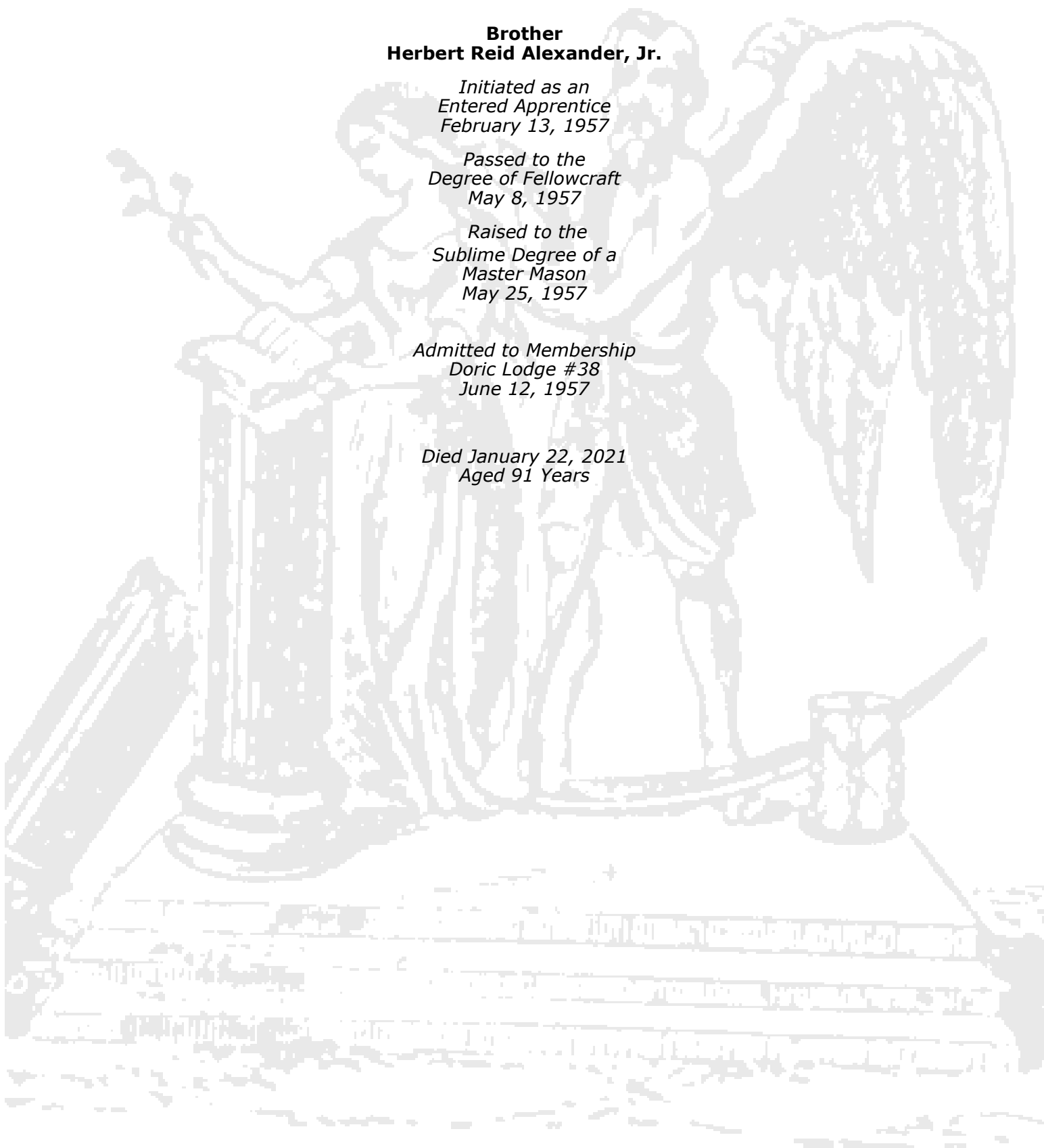

Proposed By-law Change

MacIntosh Scholarship Program

2a: The Fund shall be administered by the Finance Committee of Harmony Lodge #9 F&AM with the Treasurer serving as Chairman

2b: Not more than eighty (80%) per cent of the earned income of the Milton R. Macintosh Memorial Scholarship Fund shall be expended annually to provide educational aid and scholarship for:

First: Current Members in good standing, Children of current members in good standing or deceased members and grand-children of current members in good standing.

Second: The members or alumni of Fidelity Chapter, Order of DeMolay and the members or alumni of Woodridge Assembly, Order of Rainbow.

Third: If none of the above, The members of the Order of DeMolay and Order of Rainbow in Rhode Island.

Scholarship awards shall be capped at fifteen (15) per year with the monies equally distributed among all applicants. If there are less than fifteen (15) applicants the following formula may be used at the discretion of the committee after a unanimous vote: 1-5 applications 50% of allotted award, 6-10 75% and 11-15 100%.

The scholarship committee may by unanimous vote modify the provisions of 2B at their discretion as circumstances arise

Scholarship awards may be granted to an applicant to an accredited College, Community College, Technical or Trade School upon approval of the Scholarship Committee.

Section 2c A committee of three (3) members in good standing of Harmony Lodge # 9 F&AM shall be appointed by the Worshipful Master upon enactment of this by-law whose duty it shall be to determine recipients and respective amounts of such education aid or scholarships each fiscal year. Members shall be appointed as follows 1- 3year term 1-2year term and a one-year term. The most senior member of the committee (committee service time) will be the Chairman. The Worshipful Master shall appoint a new member for a three (3) year term at the annual communication and shall appoint a replacement member as needed to serve out the remainder of the term of the member replaced. No officer elected or appointed of Harmony Lodge #9 F&AM shall be a member of the committee with the exception of the Treasurer and Secretary of Harmony Lodge #9 F&AM who will serve as ex-officio members with no voting powers. No member shall serve more than 2 consecutive terms but after a member has at least a one (1) year break in service he is eligible for reappointment.

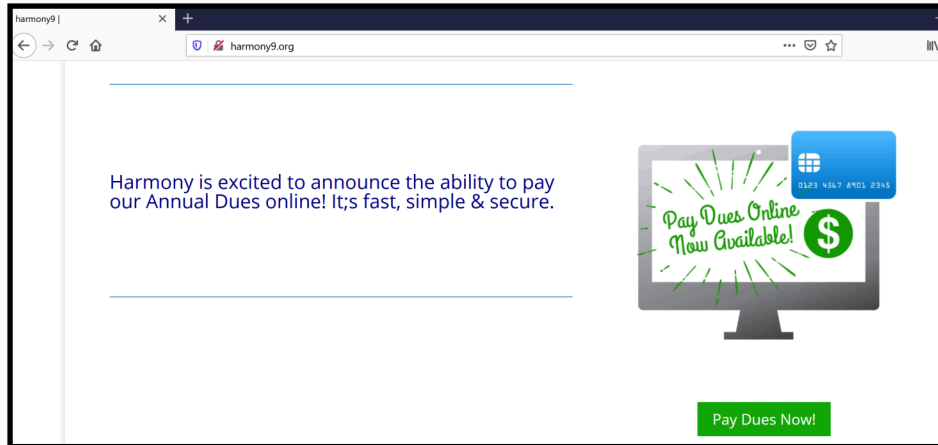

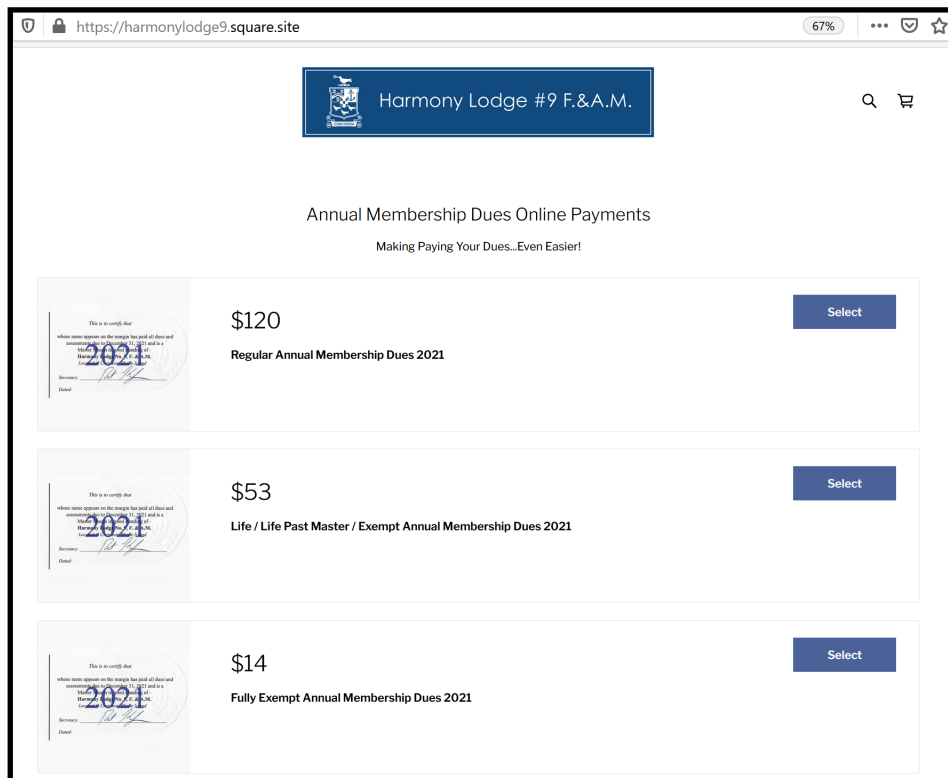

February 2021 Lodge Reopening COVID-19 Control Plan

Masonic Lodge Guidelines

- ⇒ If you feel ill, think you are ill, came in contact with someone that is ill, or believe that you might become ill if you attend lodge especially if you are older than 60 years, PLEASE DO NOT ATTEND LODGE. If you are not willing to follow the guidelines described below, PLEASE DO NOT ATTEND LODGE.
- ⇒ Each lodge building being different, it may be necessary to apply additional rules to ensure the safety and well-being of our brothers. Each lodge should use this as a guide and add any other rules that they may deem appropriate.
- ⇒ For the time being, dinners will only be allowed by using a licensed caterer and having a maximum of 30 people in the dining area if space allows.
- ⇒ Having now reopened our lodges, we will not use the Virtual Opening and Closing Ritual in a live lodge. We will now use the modified live lodge ritual that was used prior to November 2020. Meaning, the usual cipher ritual will be used with the exception of the "passing of the word". There will be no contact when "passing the word". A bow will be appropriate.
- ⇒ No lodge building shall exceed 40% of its capacity with a maximum of 125 people. This is dependent on 6 feet social distancing rules.
- ⇒ A *contact tracing log* indicating the name of every person entering the building for each meeting must be recorded in the Secretaries minutes.
- ⇒ One or two brethren shall be stationed at the entrance of the lodge to take temperatures, screen, and record the information for all who desire admittance with the following questions:
 - ⇒ HAVE YOU HAD ANY OF THE FOLLOWING SYMPTOMS IN THE PAST THREE DAYS?
 - ⇒ COUGH, SHORTNESS OF BREATH, OR DIFFICULTY BREATHING
 - ⇒ FEVER, CHILLS, MUSCLE PAIN
 - ⇒ SORE THROAT, HEADACHE, NAUSEA OR VOMITING
 - ⇒ DIARRHEA
 - ⇒ RUNNY NOSE OR STUFFY NOSE, FATIGUE
 - ⇒ RECENT LOSS OF TASTE OR SMELL, POOR FEEDING OR POOR APPETITE
 - ⇒ Have you been in close contact (less than six feet) with anyone with COVID-19 or symptoms of COVID-19 in the past 14 days?
 - ⇒ Have you traveled anywhere outside the 50 United States in the past 14 days?
- ⇒ Have you traveled to Rhode Island from another state for a non-work-related purpose in the past 14 days?
- ⇒ Have you been directed to quarantine or isolate by the Rhode Island Department of Health or a healthcare provider in the past 14 days? If so, when does/did your quarantine or isolation period end?
- ⇒ IF YOU HAVE ANSWERED "YES" TO ANY OF THE QUESTIONS ABOVE, YOU WILL BE ASKED TO LEAVE THE BUILDING. Please call to discuss when you can return to this facility.
- ⇒ Hand sanitizer and soap for washing hands will be available.
- ⇒ All brothers shall practice social distancing by doing the following:
 - ⇒ No physical contact such as hand shaking or hugging.
 - ⇒ Maintain 6 foot distance between each other.
 - ⇒ Must wear face covering if while in the Lodge building.
 - ⇒ Must wash hands frequently.
 - ⇒ Use hand sanitizer provided by the lodge as needed.
- ⇒ No contact will be made during the Opening and Closing ceremonies and the following is required:
 - ⇒ The SD must wear a face covering and latex or substitute gloves during the arranging and disarranging of the lights.
 - ⇒ The Chaplain must wear a face covering and latex or substitute gloves when attending the altar.
- ⇒ After the lodge is closed, brothers will not linger in groups larger than 5 and social distancing rules still apply.
- ⇒ Collation will not be offered after the meeting.
- ⇒ After the lodge is closed, the lodge room, dining area, and bathrooms will be sanitized by assigned brothers as needed.

PROTOCOL FOR VIRTUAL MEETINGS

PLEASE TAKE THE TIME TO FAMILIARIZE YOURSELF WITH THEM PRIOR TO SIGNING IN

MEMBER REQUIREMENTS TO ATTEND AND REMAIN

IN A VIRTUAL MEETING

"Best Practice" and/or "Preferred Protocol" shall be that members sign into the meeting 10 to 15 minutes prior to the meetings published start time so they can socialize, help each other with any technical issues, and allow adequate time for the host to verify them prior to the start of the meeting. This advance time shall be used by the host to correct and/or remove any members not properly vetted, dressed, etc. prior to the official start of the meeting.

Proper lodge etiquette for attire must be followed. This includes wearing an apron, tie and jacket.

All members must have a functioning video feed at all times during the time the meeting shall be open.

The video feed will be used in verifying the member's identity and confirm they are in a reasonably secure location (e.g. attending a meeting from the local coffee shop, or while out shopping is **not** acceptable).

Virtual backgrounds shall not be permitted in any manner.

Members shall **not** turn off or darken their video feed unless the meeting is in recess.

Members **must** use their proper names as their screen name so they can be easily recognized. Nicknames, internet handles, and the like are not be acceptable and must be corrected or rejected by the meeting host.

VIRTUAL MEETING CONDUCT

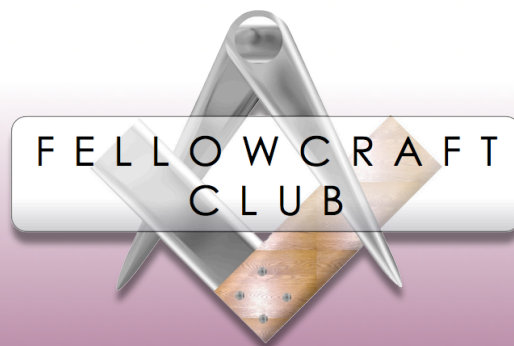
Virtual meetings should be treated with the solemnity they deserve and shall operate in the same manner as an in-person Masonic Lodge meeting, unless specifically noted otherwise in the appropriate approved ritual.

All Brethren in the meeting shall attest, on their honor, that they are properly tiling their location. This should be monitored by all in the meeting with any concerns sent as a private message to the host and/or the Worshipful Master.

No eating or drinking shall be allowed during the meeting. No talking out of turn while in a meeting. If attention is required by an individual member, a chat message may be sent to the Host or the Worshipful Master during the meeting.

Greeting and Happy New Year to you! Hoping that this communication finds you and yours in good health. The Prince Hall Grand Lodge of Rhode Island suffered a devastating loss on Christmas Day. Our Grand East, located at 883 Eddy Street, was engulfed in flames. The building is a total loss. In addition to losing our building, our Lodges, OES Chapters and auxiliary bodies lost valuable inventory. Finally, our independent income tenant, The Acacia Club, that assisted the Grand Lodge in many ways, is now inoperable. Needless to say, the Prince Hall Jurisdiction of Rhode Island is shocked, overwhelmed and distressed!

Prince Hall Masonry (PHA) has been a part of the fabric of Rhode Island since the turn of the nineteenth century. Since 1964, the building at 883 Eddy Street has been the hub for the Prince Hall Masonic family in Rhode Island. The Prince Hall Grand East is more than just a meeting place. The African American community has accessed 883 Eddy Street for many years, to celebrate as well as mourn. Losing this precious resource will indeed impair if not "stall out" not just our PHA family but the community-at-large. It is imperative that we rebuild and restore this resource not just to its members but to the whole community.
